Les Trois Vallées or **The Three Valleys** is a ski region in the Savoie region of France. Les Trois Vallées is the largest ski area in the world that is connected solely by ski lifts and slopes. It has more than 410 miles of groomed ski slopes, and offers you the ability to ski the interlinked valleys! As implied by its name, the area originally consisted of three valleys: Saint-Bon, Allues, and Belleville. The skiing area has since been extended into a 'fourth' valley, the Maurienne Valley. It is adjacent to Val Thorens. Although the town of Brides-les-Bains' main attraction to tourists is its convenience for Méribel, the village boasts its own attractions, including several health spas, a casino, the springs from which the town takes its name, a medieval church and a statue made out of piping entitled "La Manche de Chapeau."

CANCELLATION POLICIES

1. Cancellation by a participant AT ANY TIME will result in a cancellation fee. The **Orlando Ski Club** cancellation fee charged is **\$50.00 per person** if cancellation is received prior to **10/01/11**. Cancellation fee after 10/01/11 but before **12/31/11** is **\$300** per person. Cancellation after 12/31/11 but before **01/31/12** is **\$500** per person. Cancellation after 01/31/12 will result in forfeiture of whichever is greater, the deposit paid or the total cost to the **Orlando Ski Club** of such cancellation. The established cancellation date for each trip is noted on the trip's information sheet. It is the trip participant's responsibility to be aware of the established cancellation date for his or her trip. Some trips have more restrictive cancellation provisions due to airline or lodge restrictions. These restrictions will be in addition to the **Orlando Ski Club** cancellation fee.
2. All cancellations by participants shall be in writing to the trip leader with an explanation of the reasons for cancellation.
3. Participants transferring from one trip to another shall be considered as having cancelled the first trip.
4. All trip fees and monies are due on the date specified by the trip information sheet. If not received when specified, the participant risks losing their place on the trip and being treated as having cancelled.
5. Prices on all trips may be subject to change due to unforeseen increases. The club and its agents have no control or responsibility over such increases.
