Vail – The name says it all: Skiing, shopping, dining, entertainment! Vail Mountain, at 5,289 acres, is the largest single mountain ski resort in the United States, featuring seven bowls stretching seven miles wide! Most of the mountain is wide open terrain with trails of all types, from cruising runs off most Front Side and Blue Sky Basin lifts; to the wide open Back Bowls, glades, chutes, and moguls in the Northwoods area; cornices in Blue Sky Basin; and much more. Vail has a summit elevation of 11,510 with a vertical rise of 3,450 with 193 total trails (18% beginner, 29% intermediate, 53% advanced/expert). Vail also boasts 4 terrain parks, average snow fall of 346" with 32 lifts and 300 days of sunshine! The Vail Village is modeled after a Bavarian Village with pedestrian streets and rugged mountain backdrops, with convenient shuttle services running continuously. Vail is a great destination for skiers and non-skiers alike!

LODGING: Vail Spa, 2 bedroom/2 bath condos, are invitingly spacious deluxe accommodations located 200 yards from the Eagle Bahn Gondola in Lionshead. Vail Spa guests enjoy indoor and outdoor pools plus hot tubs, an exercise and weight room, steam and dry saunas, and massage therapy. Unit amenities include daily maid service, a balcony, fully equipped kitchen, iron/ironing board, washer/dryer, humidifier, and data port/modem line (two computers in lobby). For added convenience, there is on-site parking, valet service, ski storage, a game room and free super market van service twice per day.

1. Cancellation by a participant AT ANY TIME will result in a cancellation fee. The Orlando Ski Club cancellation fee charged is \$50.00 per person if cancellation is received prior to the established cancellation date for the trip the participant is canceling from. Cancellation after the established cancellation date will result in forfeiture of whichever is greater, the deposit paid or the total cost to the Orlando Ski Club of such cancellation. The established cancellation date for each trip is noted on the trip's information sheet. It is the trip participant's responsibility to be aware of the established cancellation date for his or her trip. Some trips have more restrictive cancellation provisions due to airline or lodge restrictions. These restrictions will be in addition to the Orlando Ski Club cancellation fee.
2. All cancellations by participants shall be in writing to the trip leader with an explanation of the reasons for cancellation.
3. Participants transferring from one trip to another shall be considered as having cancelled the first trip.
4. All trip fees and monies are due on the date specified by the trip information sheet. If not received when specified, the participant risks losing their place on the trip and being treated as having cancelled.
5. Prices on all trips may be subject to change due to unforeseen increases. The club and its agents have no control or responsibility over such increases.
